## MONTHLY FACT SHEET AS AT 28 APRIL 2023

The Somerston Multi Asset Fund (USO class) rose by +1.1% in the month and fell by -0.1% over the last three months.

The MSCI World Equity Index rose by +1.6% during the month and a composite of UK, German and US Government bonds fell by -0.03% in the month. Our composite reference index rose by +1.1% in the month and rose by +1.8% over the last three months.
