The Somerston Multi Asset Fund (USO class) fell by -0.6% in the month and fell by -4.2% over the last three months.

The MSCI World Equity Index fell by -2.6% during the month and a composite of UK, German and US Government bonds fell by -0.5% in the month. Our composite reference index fell by -2.0% in the month and fell by -6.2% over the last three months.
