MONTHLY FACT SHEET AS AT 30 NOVEMBER 2023

The Somerston Multi Asset Fund (USO class) rose by +6.3% in the month and rose by +3.0% over the last three months.

The MSCI World Equity Index rose by +8.3% during the month and a composite of UK, German and US Government bonds rose by +3.4% in the month. Our composite reference index rose by +6.8% in the month and rose by +1.5% over the last three months.
