The Somerston Multi Asset Fund (US0 class) rose +1.2% during the month and rose by +5.9% over the last three months.

The MSCI World Equity Index rose by +4.6% during the month and a composite of UK, German and US Government bonds fell by -1.9% in the month. Our composite reference index rose by +2.7% in the month and rose by +8.1% over the last three months.
