MONTHLY FACT SHEET AS AT 31 JULY 2026

Portfolio Objectives: To maximise risk adjusted returns through a diversified portfolio across global equities, bonds, commodities and alternative strategies.

Strategy: We adjust asset class exposure tactically and strategically to align with market cycles.

Performance: The Somerston Multi Asset Fund (US1 class) rose by +0.6% for the month and fell by -2.0% over the last three months. Our composite reference index fell by -0.3% in the month and rose by +3.4% over the last three months.
